  - c. Review of new volunteer policy Lark Asbury
    - i. Kim Reads letter from Cheryl.
    - ii. Heather Lambert speaks on choosing volunteer options that works for her teachers and her family. Addresses what this new policy does for young parents and volunteers. Worried about alienating families with young children – we will loose our community and volunteer impact. Request this to be brought to a discussion as teachers and parents and work on a case by case bases.
    - iii. Melica reports through our current volunteer base 25% Work parties wont continue due to younger siblings
    - iv. Teachers Speak this is "based upon a liability issue, not about alienating younger children of siblings."
    - v. Kim speaks on her personal experience with volunteering in the school with Max as a younger sibling. Her 5 hrs a week are down to 1 hr due to the new policy.
    - vi. Kristin Haman Speaks on the overall message that the parent community received through this abrupt communication "parents not welcome"

- vii. Ben Porter speaks to not going case by case...he supports the mommas/daddies who need to stay home instead of volunteering.
- viii. Jen Anderson "if the spirited kids could be the exception rather then the rule"...
- ix. Teachers speak up and ask for "Co-op Style" Teachers speak on "managing" their work load if their volunteer hours from parents drop due to the new policy.
- x. Wendy reads email from Lisa Richards.
- xi. Ms. Musser comments on how this feels really abrupt and understands the parents voice and reaction.
- xii. Cheryl Reviews what she learned at Beaverton school Dst. Mtg in regards to what other schools polices are. "We were operating out of district policy."
- xiii. Heather Lambert notes that there is no district policy from the research she did. It is up to each Principal/School to make their own policy.
- xiv. Jen Cooper continues to ask for teacher-by-teacher basis.
- xv. Discussions continues between Staff & Parents on the way that the policy was communicated, abruptness, request for Case by case basis and the reasoning behind the policy due to this impacting the Teachers in the classroom during instructional time.
